We hope you will also participate and take interest in this great photo contest celebrating Jeju Island,  
winner of the UNESCO Triple Crown.

**1: Eligibility**

Open to Koreans and those of any nationality.

**2: Categories of Entry**

Jeju Island

**3: Requirements and How to Enter**

a) All kinds of photos are acceptable. Color, Black and White, Digital or Analog.

b) Number of works. 3 minimum – 5 maximum (picture sequence or a set of pictures are considered as one piece of work)

c) • Photos taken by digital camera: On our homepage upload and register your photos of no larger than 3MB in jpg format from the original photos that should be over 5MB for exhibition purposes.

• Photos taken by analog camera: Scan your photos; original size should be over 5MB. Register and upload your photos no larger than 3MB in jpg format.

• Both digital and analog photos should be submitted as high resolution jpg files of a size over 5MB when chosen as one of the finalists. (We will inform you personally)

※ When you enter photos for the bonus competition through our official website, the resolution of the photos does not matter.

d) It is forbidden to manipulate or distort photos on the computer. Simple corrections such as shading, brightness, color correction or the conversion from color to black and white are allowed. However it should be clearly stated that you have corrected photos by Photoshop. If it is not stated then those entries will be disadvantaged during the judging.

e) Entry: Log on to the official website for Jeju international photo competition:

## **6: Prizes**

Total 12,500,000 KRW. (27 peoples)

Grand Prize (1) 5,000,000 KRW with a certificate of merit

Gold Prize (1) 2,000,000 KRW with a certificate of merit

Silver Prize (2) 1,000,000 KRW with a certificate of merit

Bronze Prize (3) 500,000 KRW with a certificate of merit

Fine Work Prize (10) 200,000 KRW with a certificate of merit

## **7: Schedule**

- **Submission duration: June 1, 2020 – October 30, 2020**

- Screening and Announcement: November, 2020

(Through the newspaper Dong-A Ilbo and on the official website, the winners' names will be released and we will also contact them personally.)

※A detailed schedule will be available later on the website.

(According to the organizer's discretion, the above process is subject to change)

## **8: Exclusion from selection and annulment of award decision**

a)An entry will not be considered for selection when:

The entry form is not completed and the entrant's information is not clearly written

What is written in the entry form is different from what it really is.

The entrant does not hold the copyright of the photo.

b) An award decision will be cancelled when:

The entrant does not hold the copyright of the photo.

The winning work has been awarded or selected at any other previous competition.

The winning work is found to be a plagiarism of, or closely related to other works.

(Any of the reasons mentioned above could be the cause for the annulment of an award decision, even though the work has already been awarded and could lead to prosecution for the interference in the execution of our duty.)

## **9: Copyright / Portrait Rights**

All rights of prize winning works – such as copyright, property right and the right of use etc. - belong to the organizer.

Contest participants who pass the preliminaries need to submit consent form of possible Copyright / Portrait Rights invasion.(consent form will be sent to the participants separately)

Matters not mentioned in these regulations will be decided by the organizer.

It implies agreement to all conditions and regulations of this article with the submission of the entry form and participation in the competition.
